Meeting started at 7.03pm EST

- After exhaustive deliberations, a motion to approve the draft constitution was moved by Dr. Aderoba, seconded by Dr. Sodipe. The motion carried unanimously at 7.26pm (EST).

- Dr. Ayoola informed the meeting that a Bank Account in the name of the Association has been opened, and tax ID from the IRS has also been obtained. Non-profit status or 501c is being pursued also with the IRS.
- The meeting was informed by Dr. John that a website for the Association will be developed, and deployed, with a target deployment date of September 30, 2015.

Annual Dues:

- Dr. Ayoola informed the meeting of a suggestion of \$100.00 annual dues for members.
- After much deliberation, an annual dues of \$100.00 which is non-tax deductible was approved. While members will be requested to give donations of any amount beyond the annual dues. All donations beyond the annual dues is tax-deductible.
- An annual financial year of January-December was adopted for IRS tax-filing purposes.

Membership Drive

- Dr. Ayoola implored all present to assist in an aggressive membership drive to bring other colleagues residing in the US and Canada into the Association. Members were further charged to bring at least 4-5 members to the next meeting.

First Annual General Meeting

- Dr Ayoola informed members of our upcoming First Annual General Meeting scheduled for July 8-9, 2016 in Baltimore, Maryland. This AGM is being organized in conjunction with OAU Physical Therapy Alumni Association. Members were implored to please put this on their calendar, and commit to attend.
